Introduction

The Rajarata University of Sri Lanka was established on 7th November 1995 by the Hon. Richard Pathirana, Minister of Education and Higher Education, under the provisions of the Universities Act. No. 16 of 1978 and was ceremonially inaugurated by Her Excellency the President on 31st January 1996. It was established for the purpose of providing, promoting and developing higher education in the fields of Social Sciences and Humanities, Management Studies, Agricultural Sciences, Applied Sciences subsequently expanded for Medical & Allied Sciences and Technology.

The University is the successor to the former Affiliated University Colleges at the Central, North-Western and North Central Provinces which were amalgamated to form the Rajarata University on the recommendations made by a committee appointed by the Hon. Minister of Education and Higher Education in 1995.

The University has its main campus located at beautiful surroundings of Mihintale, overlooking the Mihintale rock temple. This site is historically important as the center at which the Buddhist civilization was introduced. It is 10 km away from the ancient capital of Anuradhapura, the Centre of the world renowned hydraulic civilization. The University has six Faculties of which Faculties of Social Sciences and Humanities, Management Studies, Technology and Applied Sciences are located at Mihintale while other two, Faculty of Agriculture and Faculty of Medicine and Allied Sciences are located in Puliyankulama and Saliyapura respectively.

This University has the strategic advantage of serving the higher educational needs of the entire North Central Province and the country with the resource based available.

17. FACULTY OF AGRICULTURE

A. Introduction

Faculty of Agriculture, Rajarata University of Sri Lanka was established in 2001 with 17 students. Faculty offers a special degree programme in Agriculture with the aim of developing sustainable agricultural systems particularly focused on the production environment of the Dry Zone of Sri Lanka. The degree programme comprises eight semesters, during which courses from different agriculture-based disciplines are offered. At present, faculty consists of four academic departments, namely Agricultural Engineering and Soil Science, Agricultural Systems, Animal and Food Sciences and Plant Sciences. In addition, faculty is equipped with a Computer Unit, Faculty Cell of the Department of English Language Teaching, Faculty Farm and a Library. Soil Science, Plant Science and Animal and Food Sciences and GIS laboratories together with Agricultural Engineering workshop provide opportunities for undergraduates to improve their analytical and other skills.

The annual intake of the faculty is 175 students and on-campus residential facilities are provided for all entitled students. The total number of academic and non-academic staff employed in the faculty at present is nearly 90. The degree programme consists of core programme and a majoring module including three (03) months of industrial training. The core programme is compulsory for all students who are enrolled and spanning through the first five semesters. During the 6th and 7th semesters, students are allowed to select the majoring module on their preference. At the final semester, students should undertake an independent research project which carries six credits and required to submit a comprehensive research report based on their project and then has to undergo an industrial training.

The majoring modules offered by the Faculty, are;

- Agricultural Biology
- Agricultural Economic and Extension
- Agricultural Systems and Management
- Animal Production and Technology
- Crop Science
- Agricultural Engineering
- Environmental Soil Management
- Food and Postharvest Technology

In addition to the undergraduate programme, the Faculty offers Master of Agriculture Degree programme from 2020 and called applications for the newly introduced Master of Philosophy in Agriculture and Postgraduate Diploma in Rural Development Postgraduate Programmes. In order to increase the opportunities for Postgraduate studies in Sri Lanka, the faculty is expected to introduce a Doctoral Degree in Agriculture in 2023. Further, the Faculty is expected to introduce several Postgraduate programmes such as Master of Science in Agroecology, Master of Science in Agro-technology and Environmental Management, Master of Science in Postharvest and Food Technology, Master of Science in Plant Sciences and Master of Plant Sciences which are on the pipeline.

18. FACULTY OF APPLIED SCIENCES

A. Introduction

The Rajarata University of Sri Lanka (RUSL) was established in November 1995 by the Gazette Notification No: 896/2 of 7th November 1995 in the Administrative District of Anuradhapura. The Central Province Affiliated University College (CPAUC) in Polgolla, located at a distance of 140 km from the main campus at Mihintale was amalgamated to the RUSL as its Faculty of Applied Sciences (FASc). The immediate task of the FASc at that time was to upgrade all the students of the CPAUC who had successfully completed their Diploma requirements, to the Graduate level. On this task the FASc was inaugurated on 10th January, 1997 to commence the third year Degree Programme with a batch of 102 students, who subsequently graduated in 1998. The first batch of students who were directly sent by the UGC to follow the degree programme was enrolled in November 1997.

After functioning for nearly 10 years at Polgolla, the Faculty was finally established in the premises of the main campus at Mihintale, on 16th January 2006 upon completion of Stage I of the building complex. In 2011 completed Stage II building and Administrative block was established in this new building complex. There were two new laboratories namely Tissue Culture and Aquaculture Field Laboratory developed under the grant received from DeyataKilula Project in 2013. A new physics laboratory and lecture halls were constructed in 2017. Another new two stories building completed in 2018 to fulfill the requirements for the academic staff. In 2018, two new departments namely Department of Health Promotion and Department of Computing established. Moreover, Department of Chemical Sciences was newly established in 2020 for the Faculty.

From the inception of the Faculty, the Department of Physical Sciences offered courses in the fields of study/subjects in Chemistry, Physics, Pure Mathematics, Applied Mathematics and statistics.

The following degrees are offered by the department.

- BSc in Applied Sciences
- BSc Honours in Applied Sciences
- BSc Honours in Industrial Mathematics
- BSc (Joint Major) in Chemistry and Physics
- BSc Honors in Chemistry

The Department of Biological Sciences is focused to incorporating the different disciplines and offering the degree programmes given below

- BSc in Applied Sciences
- BSc Honours in Applied Biology (Specialization Area in Biodiversity Conservation)
- BSc Honours in Applied Biology (Specialization Area in Fisheries and Aquaculture Management)
- BSc Honours in Microbiology (got the approval from 2021)
- BSc (Joint Major) in Physics and Biology

BSc (Honors) in Information Technology (IT) and BSc in Information Technology programs are offered by the Department of computing in order to comply with the current trend and requirements of the Academia and the IT industry. The Department serves the other degree programs by offering computer science courses in their curriculum. Apart from the academic activities, the Department of Computing is providing technical support in many IT and computing related activities of the Faculty.

The Department of Health Promotion is established to develop health promotion capacity in the country through skillful graduates who are capable of ensuring optimum wellbeing of people through a wide range

of Health Promotion interventions by offering degree programmes such as BSc (Special) in Health Promotion and BSc in Health Promotion.

The Department of Chemical Sciences is offering the degree programme named as BSc Honours in Chemistry.

B. Achievements

The Faculty has managed to complete the academic sessions through alternative mechanisms such as Online lectures & Examination and the practical sessions and continue with limited work amidst the Covid – 19 Pandemic Situation.

Training Program at Mannar (Fisheries & Aquaculture)

Training Program at Horton Plains & Riverston (Forest Conservation)

Nevertheless, teaching, continuous assessments and end-semester examinations were conducted online.

- Introduces Statistics as new subjects with new course code in our new curriculum.

Establishment of Postgraduate Unit

Postgraduate Unit has been established to offer the postgraduate degree and diploma programmes in different disciplines under the separate Boards of studies; Life Sciences, Physical Sciences, Health Promotion and Health Sciences, Mathematics and Computing.

The by-Laws of the Postgraduate degree Programme; MPhil and PhD were approved by Curriculum Development Committee of the University followed by Senate of the University.

The curriculum of Postgraduate Diploma in Child Protection has been revised and its under the review.

The by –Law for the Postgraduate Diploma in Child Protection has been developed.

Establishment of Faculty-Industry Collaboration Cell (FICC)

The new FICC proposed strives to develop a strong university-industry collaboration programs at the Faculty of Applied Sciences, Rajarata University of Sri Lanka. The FICC contributes relevant expertise and knowledge to industries on a resource base, and create new possibilities for innovation through multidisciplinary research approach for the development of the nation. In this context, the discovery –driven culture of the university with the innovation-driven environment of the industry through faculty-industry collaboration plays a vital role of the cutting-edge research as a source of competence and delivering solutions to pressing social issues/challengers including, health, water, energy, clean air and foster economic competitiveness.

Introduction of Short courses in Health Promotion

The steps were taken to introduce the Short Courses in Health Promotion for visiting collaborators and overseas students. There are 03 short courses with one week, two weeks and one month durations.

International collaborations

- Ms. Satu Susanna Latina, Student from Master of Global Health program at the Sahlgrenska Academy, University of Gothenburg, Sweden, completed 10 weeks internship at the Department of Health Promotion from 03.11.2021 to 16.01.2022.
- Ms. Christine Joyce Awuor, Student from Master of Global Health Program of the School of Public Health of the University of Sydney, successfully completed a 6 weeks placement in the Department of Health Promotion.

Appointing an honorary professor

Prof. Diyanath Samarasinghe, a senior psychiatric and a consultant to Health Promotion study program has been appointed as an Honorary Visiting Professor for the Department of Health Promotion.

- Dr. (Mrs.) P. K. Premachandra is working on developing a biomarker database and a tool kit to detect the proteins responsible for chronic kidney disease of unknown etiology (CKDu) at an early stage, in collaboration with National Hospital, Kandy – AHEAD grant.
- A paper was published in an international journal in 2021 from one of the above undergraduate projects by Department of Physical Sciences
- Eight abstracts were published by academic staff in international and local research conferences and published eight publications including in refereed indexed Journals, e-journals and other journals by Department of Physical Sciences
- Department of Health Promotion completed a research project in collaboration with Save the Children on Home Based Early Childhood Care and Development (HBECCD). This project has adopted action research approach and conducted in four selected divisions of a tea estate in Nuwara Eliya district.
- Department of Health Promotion completed a research project in collaborated with World Food Program aiming to evaluate the benefits of a community-based health promotion intervention on improving nutrition and selected nutrition related aspects of community members.

Staff members of the Department of Health Promotion published 07 research articles and 04 conference presentations during the year 2021

Seven publications from Staff and Seven publications from students were published by The Department of Computing.

C. Failure And Justification

- Covid 19 pandemic tremendously disrupted the smooth functioning of the academic and research programmes resulting cancellation and rescheduling most of the study programmes. As the students were not available at the University, during the major part of the year and lack of facilities.
- Majority of the programmes planned for the period concerned had to be cancelled or rescheduled, as the students were not available at the University, due to Covid 19 pandemic during the major part of the year.
- Several field visits were rescheduled due to Covid 19 Pandemic situation
 - (a) Unable to properly schedule industrial training program
 - (b) Face some difficulties in conducting lectures properly because of the shortages of lecturers in mathematics and statistics.
 - (c) The curriculum revisions of Physics, Biology, Chemistry and Information Technology were not able to do due to the Covid-19 Pandemic, since the experts and stake holders had difficulty in commuting.
- Certain exams have been postponed due to Covid-19 pandemic. But necessary actions were taken to conduct exams via online mode and completed successfully.
- Planned activities, plans and targets of the Department of Health Promotion for year 2021 could not be achieved due to COVID-19 pandemic situation. However, the department made optimum effort to modify and implement those tasks.

Furthermore, Master of Business Administration (MBA) and Bachelor of Business Administration (Gen.) are also conducted by the faculty. The faculty has also initiated a Doctoral Degree and it has been principally approved by the UGC.

The mission of the Faculty of Management Studies is to provide quality education in Management Studies and leadership with practical skills and to conduct research giving due consideration to the changing environment

THA houses the University Professorial Units in the major clinical disciplines equipped with modern diagnostic and management facilities. Staff of all Clinical Departments provide services as honorary consultants at THA. Community practice area consists of a socio-economically diverse population that enables comprehensive training in primary and preventive care. Community care services that are provided by FMAS include services for mentally disabled children, outreach clinics, health promotional activities and maternal and infant care services, especially related to averting child malnutrition and improving maternal morbidity surveillance. The Faculty continually strives to uplift the standards of the institution, by paving the way for students to reach their full potential. Throughout the short history of the Faculty our undergraduates have secured high ranks in the common merit order and excelled in various postgraduate courses.

C. Failure & Justification

- Though the research output is commendable, we were unable to achieve our full potential due to the lack of financial support from the university, inadequate academic staff who are overloaded with academic teaching work and the non-availability of a skilled technical staff and management assistant.
- Most of the planned activities were not conducted due to the COVID-19 pandemic.

21. FACULTY OF SOCIAL SCIENCES AND HUMANITIES

A. Introduction

The Faculty of Social Sciences and Humanities was established with the inception of the university in 1995. At present, the faculty comprises a student population of around 1795. In 2021, the faculty enrolled 549 students. The faculty of Social Sciences and Humanities comprises 7 Departments. 22. FACULTY OF TECHNOLOGY

A. Introduction

The Faculty of Technology was officially gazetted on the 14th of September 2017 as the 6th Faculty of the Rajarata University of Sri Lanka (RUSL). The initiative to launch the Faculty of Technology came from within the Faculty of Applied Sciences (FAS) of RUSL in January of 2015, with the intention of expanding the overall current academic structure of the institution. Through this initiative, it was hoped that the inadequately elaborated academic structure be improved as compared with other Sri Lankan universities of similar size and scope.

The Faculty of Technology comprises five Departments, each leading to their respective degree programmes: 1- Bio Process Technology (BPT), 2- Electrical & Electronic Technology (EET), 3- Food Technology (FDT), 4- Information & Communication Technology (ICT), 5- Materials Technology (MTT). All degree programmes follow the SLQF 6 format spanning a study period of 4 years. Students who have sat for their G.C.A. A/Ls under the technology stream are selected for these degree programmes and are initially grouped into Biosystems Technology, Engineering Technology and Information & Communication Technology. The Biosystems Technology and Engineering Technology students are then branched out into Bio Process and Food, and Electrical & Electronic and Materials Technology, respectively, during their second year of study, taking into account their preference, academic performance as well as the availability of resources and market demand.

Compared with existing courses in the country, the Technology degree programmes are more vocational, heavily focusing on nurturing hands-on skills. Industry tie-ups and collaborations were incorporated from the very beginning itself into the curricula. This is deemed an important aspect given that students from all degree programmes have to go for an industrial placement and a semester-long research project during their final few semesters of study.

In addition to the funding received from the University Grants Commission (UGC), the Faculty also receives financial support from the Asian Development Bank (ADB) for infrastructure and human resource development. The Faculty has taken in five batches of G.C.E. A/L Technology stream students to date, with the senior most students having completed all their examinations and awaiting the convocation. Currently, the faculty is hosting five batches adding up to 1177 students while there are 37 permanent staff members and 9 temporary staff members involved in teaching.

B. Achievements

The Engineering workshop and the ceramic pilot plant of the Materials Technology Department have been completed and handed over to the faculty in November 2021. The engineering workshop was fully equipped with the latest state of art equipment purchased under the Science and Technology Human Resource Development Project (STHRD). Construction of phase II and III buildings are in progress despite the delays caused by the covid 19 pandemic. The building complex funded under the STHRD project was commenced its construction in November 2021. The laboratory complex is planned to complete within 18 months and the entire project should complete in 30 months.

The first Technology batch, 15/16 intake, completed their academic activities and will be graduating in 2022 convocation. The 16/17 batch completed their industrial training and the faculty admitted its 5th batch, 19/20 batch, with a virtual inauguration ceremony. While most of the academic activities were taken place through online, the faculty started to bring students physically into the University for practical classes. The faculty also conducted several rounds of examinations for all the batches through

online platforms for the first time. A separate set of examination bylaws were developed to conduct online examinations.

The faculty managed to secure an additional grand of LKR 25 million from the Asian Development Bank to assist the University to fight Covid 19. The faculty utilized that fund to provide equipment required to promote online teaching in all the faculties and provided wifi facilities to all the student hostels.

The Department of Bioprocess Technology (BPT) was able to secure a competitive research grant from Oracle for high performance computing projects worth 100,000 \$ credits. The researchers in the department published 18 SCI papers 1 international book chapter and 5 abstracts. Department conducted a 3 months online workshop for the Community Directed Healthcare Volunteers (CDHCVs) team consisting of 15 community members from the Madawachchiya MOH area in Anuradhapura, 30 undergraduate and graduate students from the Rajarata University of Sri Lanka, and 15 Healthcare volunteers from the 'Sarvodya' non-governmental organization (NGO) from 24th September to 24th December 2021. Conducted an introductory webinar with regards to the Open call 2021 of the World Mosquito Program (WMP) in Sri Lanka held in collaboration with the University of Rajarata Sri Lanka at 10.00 am - 10.30 am (SL time/ 4.30am GMT) on the 8th of November, 2021 via the Zoom platform. The department has also purchased several major equipment through STHRD project.

1. UPLC with photodiode
2. Digital PCR
3. Glove box workstation
4. Bead homogenizer
5. Nanodrop

The Department of Electrical & Electronic Technology purchased several high end equipment for teaching and research purposes. A pneumatic trainer kit, a state of the art robot arm, electrical machines and drivers, and telecommunication trainer kits are among those. The department recruited one senior consultant and a lead consultant to review the Electrical & Electronic curriculum according to the accreditation guidelines.

The department completed the self evaluation report for the IESL accreditation and submitted it to the accreditation consultant.

ICT department achieves success with different areas. Department purchased new IOT equipment and equipment related to the computer networking. With the equipment students can have hands on experience in the practicals with updated equipment. Students organize a workshop related to the IT industry and conducted by an industrial expert. The department has the process of ongoing review of the curriculum with two consultants. Part of the curriculum review department conduct sessions with Lecturers, students, and relevant external parties. Also developing the curriculum according to the CSSL guidelines. Also updating the curriculum according to the industrial and academic standards. Also, conduct a session with all the lecturers and the demonstrators to express their ideas about the development of the department and curriculum as part of the ongoing curriculum review.

Department of Food Technology has purchased some major equipment under the STHRD project. These included Texture analyzer, Refractometer, Viscometer, Water activity meter, Pharmaceutical refrigerator, Chest freezer and Vortex machine. Also the academic staff of the department has published 3 journal articles in 2020.

The Faculty of Technology organized the annual research symposium of the Rajarata University of Sri Lanka, ISymRU for the year 2021. The name ISymRU was proposed by the Faculty of Technology and the University has decided to continue that name as the name of the University Symposium from this year. Due to the Covid 19 pandemic situation, the symposium was conducted virtually and several world renowned experts have participated as invited speakers and several webinars were held to cover a wide range of specialties. The financial assistance was provided by the University and the Science and Technology Human Resource Development Project of the Asian Development Bank.

The Faculty of Technology introduced the first ever University research award ceremony to honor the best researchers in the University. As the University is celebrating its 25th anniversary, the faculty decided to honor the past vice chancellors of the University at the same event. The Vice Chairman of the University Grants Commission, the Chancellor, and the Vice chancellor of the University have participated as chief guests. This event was funded by the Science and Technology Human Resource Development Project of the Asian Development Bank.

C. Failure and Justification

Several failures occurred during the time due to COVID 19 pandemic. For most of the part, the students were at home. Therefore, the teaching-learning process was entirely shifted to online.

Several failures occurred during the year due to the lack of enough academic and non-academic staff members. These include

- delays in regular duties
- poor resource management
- unavailability of consumables in labs for practical on time
- academic staff members spend majority of their time on administrative and nonacademic duties instead of academic duties
- Being a newly established faculty, the present staff is struggling to manage the workload. In addition to the inadequate staff the faculty is also facing severe shortage of space for laboratories and office spaces. It also caused several failures, such as
- lack of proper work space for lecturers
- last minute cancellation of lectures due to lecture hall scheduling clashes with other faculties.
- Too much workload for the staff members as requested cadre was not approved
The faculty is struggling to cope up with the limited facilities to cater the increasing student numbers.
- Hostel facilities have become a major concern as the entire Mihintale area was occupied with students.
- Inadequate Canteen facilities causes delay in academic activities as students struggle to get their meals on time due to long ques.
- Lectures, practical classes and exams were conducted until late night to finish the study program on time. Students and staff had to face several issues due to lack of proper transportation facilities in late hours.

D. Future Plan

Infra-Structure Development

Constructing buildings:

- Phase II and III of the UGC funded building: # story building is planned to complete by August 2022.
- ADB funded building complex: Construction was started in November 2021 and the lab complex is planned to complete on April 2023 and the entire project should complete in April 2024.

Curriculum Development

- Curriculum revisions of all the departments have reached the final stages and will be completed within 2022.
- The Self Evaluation reports of all the degree programs were completed and received consultant comments.
- Launch of business incubators.
- Organize the annual stakeholder meeting and industrial consultative committee meetings.
- Starting Postgraduate degrees

Human Resource Development

- Recruitment of Faculty members who have specialized in areas which are relevant to the Technology degree programs
- Probationary lecturers will be sent to their post graduate trainings using ADB financial assistance.
- Foreign experts will be invited to the faculty to conduct workshops on the latest technologies available and train academic staff.
- Several short term training will be organized for the academic and non academic staff of the faculty through the STHRD project.

23. LIBRARY NETWORK

A. Introduction

History of the Library

The Rajarata University of Sri Lanka was established on the 31 st January 1996 under the gazette notification No: 896/2 of 7th November 1995, and the University act 16.08.1978 by amalgamating resources of affiliated university college in the central, North western and north central provinces. The library system of Rajarata University was started on 2nd September 1996. The first librarian of Rajarata University Library was Prof. Piyadasa Ranasighe (1996-1998), followed by Mr. Kapila Jayalal Sirisena and Mr. Gamini De Silva (1999-2007). Mrs. Hema Wijethunga (on sabbatical placement -2007-2009) and Mrs. A.S Siriwardana is the present Librarian of the University from 2013 to date.

Library Profile

The library of the Rajarata university library is the heart of the institution for acquisition, organization and dissemination of knowledge as widespread tree. The library provides services to the university user community such as undergraduates, postgraduates, academic staff members, executive and non-academic staff members. In addition, the library serves to the researchers and outside community in the region.

The Faculty Libraries

The library system of the Rajarata University of Sri Lanka is consisted with main library and four faculty libraries in different locations. Main library, Faculty of Applied Sciences and Faculty of Technology libraries are located within the Mihintale premises and serves to the Faculties of Social sciences and Humanities, Management studies, Applied Sciences; Technology consecutively. The Agriculture Library located in Puliyankulama and Medical Faculty library located in Saliyapura. The clinical library located in the Teaching Hospital in Anuradhapura.

Library Staff

Currently the staff of the library consists of Library Academics (07), Administrative (01), para - professionals and supportive staff (38).

Library Collections

Materials that can be found in the main library consist of textbooks, journals, magazines, newspapers, government documents, special collections, reference materials, past project reports, dissertation, past questions papers and e-resources. All these are materials that have been acquired based on the subject curriculum. The library resources are available in both print and electronic formats.

Library provide the service of Online journal databases which can be assess full text journal titles in Medicine, Agriculture, Applied Sciences, Social Sciences, Computer Sciences and management disciplines through the CONSAL. The library subscribes to many current journal and these are intended to help the users to keep up their novel knowledge with the current trends. The book collection comprises of text books in various subjects disciplines and general knowledge which are mainly useful in the all faculties of the Rajarata University.

The Library has successfully converted existing library data base management system with the open source software “KOHA”. Library could give remote access to user community, using latest information and communication technology.

An institutional repository is an online collection of an institution's research output. Current awareness services will notify users about new topics and information about their specific research needs via e mail, verbally and through notices. The library support users to conduct their researches and provide necessary information for their research works and ongoing activities via e mails and other ways.

- **Audio Visual resource service & Wi-Fi Access**

The e- resources unit of the main library provides access to electronic databases, Internet and CD/DVD collection. It has number of computers and users can search download and share information. They can also access to full text scholarly articles free of charge. It gives easy access to all electronic materials in the library. The center equipped with Wi-Fi surf area of the library building and it allows connecting student's laptops, i-pads, smart phones and portable devices to access electronic information.

- **Photocopying Facility (Private)**

The Library offers photocopying facilities to users. All materials except thesis and research reports could be photocopied by users. The scanning and book binding are also providing by them.

- **News Clipping Service**

Library maintains a paper clipping collection for series of subjects. Library planned to convert them to a digital archive through scanning those articles. It includes up to date information and users will able to share, download information through that service.

B. Achievements

- **User Awareness Programs**

Six Library Orientation Programs were conducted for Students in Faculty of Management Studies, Agriculture, Medicine, Social Sciences and Humanities, Applied Sciences and Technology. Thirty three (33) awareness programs have been successfully done via Zoom platform due to the Covid 19 pandemic.

- **Online Document Delivery Services**

The Library System of the Rajarata University of Sri Lanka has initiated an online resource delivery service due to the COVID 19 pandemic situation. Requested library materials have been sent via emails to the patrons to maintain their reading habits even in the midst of the pandemic. Library delivered around 4000 documents throughout the year.

- **Online Registration**

Due to the Covid – 19 pandemic the library introduced the online user registration service and we have successfully enrolled 2019 Management student intake via online.

- **Online Clearance**

The library introduced the online clearance service due to the Covid – 19 pandemic and we have successfully completed the clearance process of 2014/ 2015 Management Students via online.

- **Train Staff for working during a pandemic**

Develop the skills and attitudes of the staff to work during pandemic using the modern technology.

- **The Community Outreach Activities**

Workshops and Seminars are periodically organized by the Library System, Rajarata University of Sri Lanka on the field of Library and Information Sciences to the public librarians, public library professionals, school libraries, private Librarians. Library awareness session has been conducted for public librarians and school librarians.

- **Online Past Papers Delivery Service**

Uploaded the past question papers to the university Learning Management System (LMS) as students could not be able to access past papers database within the university premises.

C. Failure and Justification

1. Lack of e-resources

D. Future Plans

- **Digital Library**

The Library System of the Rajarata University of Sri Lanka has a plan to develop a digital library that stored digital formats of book chapters locally and can be accessed via Intranet. This proposed digital library can be implemented using Dspace open-source software and this should be accessible via the Intranet. Through this, students will be able to get all the information that they obtained from the online document delivery service. Further, library staff also will be benefited as they could be able to access all the scanned documents via the digital library.

- **Turnitin Plagiarism Software Subscription**

The library system of Rajarata University of Sri Lanka is planning to implement Turnitin plagiarism software by considering its extreme role in the knowledge market and advantages to the academic community. At the initial stage and we are planning to create Instructor accounts for every permanent academic staff member and planning to develop a “Plagiarism policy for Rajarata University of Sri Lanka”.

- **Establishing an Editorial Unit**

Library is planning to establish an editorial unit in the library premises to facilitate the research activities of the university community.

- **In- house Training**

Library is planning to conduct in-house training program for the library staff. Resource persons will be academic staff of the library.

- **Remote access facility to Students**

The library system is planning to provide remote access accounts to all the students. With the remote access credentials students will be able to login to the e-databases remotely.

- **Establish a CSR Center**

The Library will be establishing a CSR Center in the Main Library. The main Objective of this CSR Center is collecting and maintaining the information of the conducted CSR activities

26. CENTRE FOR DISTANCE AND CONTINUING EDUCATION

A. Introduction

Rajarata University of Sri Lanka is located at Mihintale about 20 km to the East of Anuradhapura, ancient Capital City of Sri Lanka. The University has Six Faculties, namely the Faculty of Agriculture, Faculty of Applied Sciences, Faculty of Management Studies, Faculty of Medicine and Allied Sciences, Faculty of Social Sciences and Humanities and Faculty of Technology. Faculty of Agriculture is located at Puliyankulama, and Faculty of Medicine and Allied Sciences is located at Saliyapura while the other facilities, units and centers are on the main campus, Mihintale. The University Grants Commission (UGC) and the Ministry of Higher Education have prepared certain guidelines in order to provide learning opportunities to a wider spectrum of students through external programs, with the intention of producing skilled, knowledgeable and employable Graduates, Diplomats and Certificate holders. Universities were requested to establish a separate administrative structure to handle activities of external academic programs effectively and efficiently, this reducing the workload normally handled by the academic departments and faculties. Different faculties of this university offer a number of external degree programs and extension courses at certificate and diploma levels.

The Centre for Distance and Continuing Education (CDCE) of Rajarata University of Sri Lanka is the independent administrative body established to coordinate activities of the external academic programs. The CDCE was established as per the UGC Circular No. 932 with the approval of the Council of the University on 24th October 2011 (155th Council Meeting). Since then, the CDCE was functioned at the Faculty of Applied Sciences until 31st March 2014. The CDCE was shifted to the main administrative building with effect from 1st April 2014.

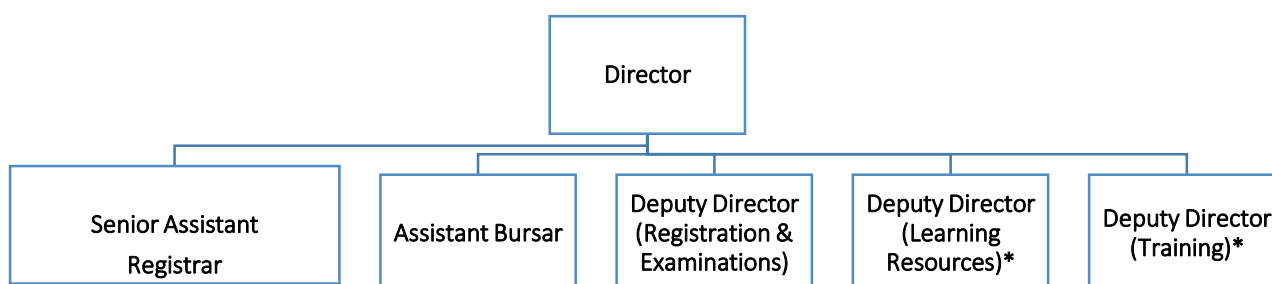

27. STAFF DEVELOPMENT CENTRE

A. Introduction

The Staff Development Centre of the Rajarata University (SDC) was established in 2005 with an objective of developing competencies and promote career development of all categories of staff at Rajarata University. The main aim of the SDC is to make the university teaching and learning process more effective, more relevant, student oriented and to achieve international standards by placing special emphasis on training of new recruits to the academic staff in innovative teaching methodologies. Moreover, SDC is committed to promote the development of skills and competencies necessary for more effective and efficient performance among all members of the staff of the University.

B. Achievements

Programs Completed

a) Academic Staff Induction Program leading to Certificate of Teaching in Higher Education (CTHE)

The Staff Development Center annually offers an induction program for university academic staff. This program is based on the training manual published by the University Grant Commission. Participants are offered Certificate of Teaching in Higher Education on successful completion of the program. The proposed training program was to cover eight major areas organized into separate modules.

In year 2021, academic staff induction program started in April and Completed in August. Thirty (30) participants registered and successfully completed this program. In addition to 26 participants from Rajarata University, there were three participants from Bhiksu University of Sri Lanka and IDM International Campus.

b) Kanimadala Program

SDC together with the Career Guidance Unit of the University conducted a training program for non-academic staff members to develop their skills in personal and professional life.

This program was conducted on three days – 29th, 30th & 31st March and 63 staff members participated in this session.

c) Training Program for Academic Department Heads and Executive Officers

The SDC introduced a training program for executive staff and the head of the academic department on university financial and administrative procedures. This training program consists of 8 modules and planned as a five-day program to be conducted on one day per week for five weeks. In year 2021, training was started in November and altogether 35 staff members participated for this program. Steps are taken to continue this program as an annual training.

d) Driver's Workshop

This training program was mainly organized for the drivers working in Rajarata University of Sri Lanka. Main objectives of the program were to train the participants as professional drivers. Training was conducted on 06th January 2021 and 21 participants participated.

C. Failure and Justification

- There were delays in delivering and completing programs – specially the academic staff induction program due to travel restrictions and university closure during pandemic situation.
- Difficulty in bringing in resource persons for training programs due to pandemic situation was a challenge. Some of the planned programs could not be conducted due to the reason.

D. Future Plan

Introduce two more annual training programs for academic and non-academic staff members.

Conduct more training programs targeting all categories of staff within next year

Introduce programs which are open for staff from other universities to generate income for future staff development activities.

28. INFORMATION TECHNOLOGY CENTRE

A. Introduction

The Information Technology Centre of Rajarata University of Sri Lanka was established along with the establishment of the university in 1996, in view of enhancing ICT skills of undergraduates. The center was administered directly by the vice chancellor and its functions were supervised by a director appointed by the vice chancellor. The Information Technology Centre initially focused on conducting basic computer awareness programs for undergraduates of Faculty of Management Studies and Faculty of Social Sciences and Humanities. As the university expanded, the Information Technology Centre became the prime ICT service provider of the university. Since the initial scope of the center had been expanded, and to reduce the administrative burden, starting from 2011, the council of the university appointed a director to look after academic and administrative matters. The director is an academic member with sound knowledge in ICT. The term of the director is three years.

The center opens from 8:00 am to 6:00 pm during week days and from 8:00 am to 4:00 pm on Saturdays. Apart from the normal opening hours, on special requests, with the approval of the vice chancellor, the center opens till 8:00 pm during study leave and examination periods. The staff of the Information Technology Centre consist of an Instructor in Computer Technology, a Systems Analyst, an Asst. Network Manager, Technical Officers, and a Lab Attendant.

B. Achievements in the year 2021

Information Technology center was able to facilitate all related academic works of the faculties situated Minintale premises in the year.

1. Started the process of the shifting server room from the administrative building to the building presently Information Technology Center established.
2. Got Separate entrance to the IT Center.
3. Lunched a new website for the University.
4. Provided Wi-Fi facilities to the 90% of the Student Hostels.

29. CENTRE FOR QUALITY ASSURANCE

A. Introduction

The Internal Quality Assurance (IQA) is streamlined under the Centre for Quality Assurance (CQA) and Internal Quality Assurance Cells (IQACs) and are guided by the by-laws on IQA activities, which are in line with IQA Manual (2013). IQACs are being revamped to extend their role across all possible spheres of work with a view of enhancing quality. Each activity will be a responsibility of a member of the IQAC and she/ he carries out the functions with a working committee approved by the Faculty Board or CDCE, to make the functioning more efficient and to involve as many staff in all sectors in IQA. CQA has taken the lead of preparation of several policy documents such as Quality Assurance and Enhancement Policy, Curriculum Development Policy, Human Resource Development Policy, Student Assessment Policy. It is also in the process of preparing several other policy documents. CQA takes the initiatives and guides the processes of External Quality assurance (EQA). The CQA Faculty coordinators and Deans of the Faculties are responsible for IQA within Faculties. The IQAC of CDCE also operates in a similar mode, Director/ CDCE replacing the Dean. The management committee has been converted to the Senate Standing Committee of the CQA chaired by Vice-chancellor. CQA matters appear as a different item in the Senate that is documented under Centers and Units of the university.

30. UNIVERSITY BUSINESS LINKAGE CELL

A. Introduction

The University Business Linkage Cell of the University of Rajarata was established in 2018, through the initiative of the University Grants Commission (UGC) Circular No 10 /2016 funded by AHEAD Accelerating Higher Education Expansion and Development which is a World Bank-funded Sri Lankan government operation to support the higher education sector. 01.NOTES TO THE FINANCIAL STATEMENTS

1.1 CORPORATE INFORMATION

Rajarata University of Sri Lanka is a fully Government owned higher educational institute established under the Universities Act No 16 of 1978 and subsequent amendments thereto. Rajarata University of Sri Lanka currently operates with six faculties and situated in North Central Province, Anuradhapura district, in Sri Lanka.

1.2 BASIS OF PREPARATION

The Financial Statements of the Rajarata University of Sri Lanka have been prepared on accrual basis and under the historical cost convention unless stated otherwise. The Financial Statements are presented in Sri Lankan Rupees (Rs) which is the University functional and presentation currency and all values are rounded to the nearest rupee value.

The significant accounting policies are disclosed in sections 1.3 and 1.4 under this note.

The Statement of Financial Position, Statement of Financial Performance, Statement of Changes in Equity and the Cash Flow Statement together with the accounting policies and notes have been prepared in compliance with the Sri Lanka Public Sector Accounting Standards (SLPSAS) issued by the Institute of Chartered Accountants of Sri Lanka and the requirement of the Universities Act No 16 of 1978 and subsequent amendments thereto.

The net financial result of the ordinary course of business of the University for the year under review is shown in the Statement of Financial Performance. All assets and liabilities of the University are shown in the Statement of Financial Position. In addition, the Cash Flow Statement includes the cash inflows and outflows of cash and cash equivalents of the University.

1.3 ACCOUNTING POLICIES

1.3.1 APPLICATION OF SLPSAS

The University has followed the Sri Lanka Public Sector Accounting Standards (SLPSAS) when preparing and presenting financial statements for the year 2021. In this context, all SLPSAS mentioned in the Statutory Report have been followed unless stated otherwise.

1.3.2 CHANGES IN ACCOUNTING POLICIES

The University has adopted the Public Sector Accounting Standards when preparing and presenting the Financial Statements of the University unless stated otherwise. No significant changes in accounting policies have been taken place during the year under review.

1.3.3 SIGNIFICANT ACCOUNTING JUDGEMENTS, ESTIMATES AND ASSUMPTIONS

Preparation of the Financial Statements of the University requires the management to make Judgements, Estimates and Assumptions, which may affect the Income, Expenditure, Assets, Liabilities and disclosure of Contingent Liabilities, as at the end of the financial year. When applying the accounting policies the key assumptions made relating to the future estimates and other aspects are discussed below.

1.4 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

1.4.1 FOREIGN CURRENCY TRANSACTIONS AND BALANCES

All foreign currency transactions recognised to functional currency at the rates of exchange rates prevailing at the time the transactions occurred. Monetary assets and liabilities denominated in foreign currency are translated to functional currency (Rupees) at equivalent exchange rates prevailing as at 31/12/2021. The balances of Residential Foreign Currency (RFC) account as at reporting date recognised into functional currency at the rates of the same date. The gain/loss recognized on foreign currency is shown separately in the note no. 31 and net result credited to the respective fund account separately.

1.4.2 TAX

Income tax

University is not liable to pay income tax on its income of the ordinary course of the business according to the prevailing tax regulations.

PAYE tax

University currently remits PAYE tax deducted from monthly salaries of the only employees who are liable to pay income tax on their salary income with their written consent.

1.4.3 PROPERTY ,PLANT AND EQUIPMENT (PPE)

The SLPSAS 07 requires an entity to review the residual value and the useful life of an asset at least at each annual reporting date and, if expectations differ from previous estimates, the change (s) shall be accounted for as a change in Sri Lanka Public Sector Accounting Standards an accounting estimate in accordance with SLPSAS 3, Accounting Policies, Changes in Accounting Estimates and Errors.

DEPRECIATION

Depreciation is calculated by using straight-line method at following rates on the cost or revaluation value of all Property, Plant and Equipment, books and periodicals and cloaks.

1.4.4 BIOLOGICAL ASSETS

The treatment for the biological assets has been made in terms of SLPSAS 18, Agriculture. Biological assets of the University are shown as a separate asset in the Statement of financial position. Biological assets are measured on initial recognition and at subsequent reporting dates at fair value less estimated point of sale costs, unless fair value cannot be reliably measured. The gain on initial recognition of biological assets at fair value, and change in fair value of biological asset during the period considered as net surplus/deficit.

1.4.5 SHORT TERM INVESTMENTS

The University has invested its unutilised funds that were received for external academic programs, research, projects and other ancillary activities temporally on term deposits at the State Banks on highest interest rates after calling competitive bids from states banks. The interest accrued for same has been adjusted to the respective ledger accounts and shown as income in the statements of financial performance. Similarly, the funds received for scholarships and medal awarding has also been invested in term deposits at the State Banks. Further, details on investments and interests income on investments are disclosed in note 03.

1.4.6 INVENTORIES

Inventories of the University have been physically verified and valued at cost on First in First out basis (FIFO) as at 31st December 2021. The inventory of the University classifies mainly in to Stationery, Building materials, Chemicals and glassware and other inventories. The cost of chemicals and glassware purchased from research grants are fully charged to the respective research grants as expenditure at the time of purchasing. However, material inventory balances remained at the end of the year as per the physical verification reports have been adjusted to the respective accounts.

Further details on inventories are disclosed in Note 10.

1.4.7 TRADE AND OTHER RECEIVABLES

Trade and other receivables are stated at the estimated amount as per SLPSAS 01 that it is due to be received within twelve months after the reporting date. No provision has been made for bad and doubtful receivables and payments.

1.4.8 CASH AND CASH EQUIVALENT

Cash and cash equivalents are disclosed in the statement of financial position and the cash flow statement comprises balances of Current and Residential Foreign Currency (RFC) accounts. Further details on cash and cash equivalents are disclosed in the Note No 2 of the statement of accounts.

1.4.9 GRATUITY

The liability recognised in the statement of financial position is the present value of the gratuity obligation calculated according to the Projected Unit Credit Method indicates in the SLPSAS 19, Employee Benefits. According to the Commission Circular 05/2019 Academic allowance and Compensatory allowance were considered for gratuity provision as at 31/12/2021. The payment of gratuity is made according to the provisions stipulated in the Gratuity Act No 12 of 1983.

1.4.10 UNIVERSITY PROVIDENT FUND AND EMPLOYEES' TRUST FUND

Employees of the University are entitled for University Provident Fund (UPF) contributions and Employees Trust Fund (ETF) contributions in line with respective statutes and regulations. The University contributes defined percentages of (15%) and (3%) on gross emoluments of employees to an approved employees' provident fund and to the employees' trust fund respectively, which are operated externally.

Further, Employees' pension scheme is also operated as a retirement benefit to the University employees in contributing 8% to the pension fund from the University. This pension fund currently administer by the University Grants Commission.

1.4.11 GOVERNMENT GRANTS

Government grants for capital and recurrent expenditure recognised only when they are received by the University keeping in line with the provisions of the SLPSAS 01. The recurrent grant received for the year has been recognised as income in the statement of financial performance and capital grant received by the University has been recognised and accounted in the capital accounts through capital grant spent and unspent accounts and the effect of that are directly incorporated with the statement of financial position.

1.4.12 PROVISIONS FOR CONTINGENT LIABILITIES

Provisions are recognised when the University has a present obligation as a result of a past event and it is probable that an outflow of resources embodying economic benefits will be required to settle the obligations and reliable estimate can be made of the amount of the obligation. No provisions for contingent liabilities have been made as there were no cases where the legal obligations have been accurately estimated. Therefore, the liabilities in connection with the legal cases for which the financial obligations are not estimated clearly and exactly are shown as a note and all the adjustments and disclosures are made in keeping with the provisions of the SLPSAS 08. The contingent liabilities in connection with legal cases instituted against the University as at 31st December 2021 are amounting to Rs. 38.5 million. However, the amount of compensation cannot be estimated reliably and thus no provisions have been made the financial statements.

The details of contingent liabilities are given in Annex - 01.

1.4.13 CONTINGENT ASSETS

Details of the contingent assets which are available at the accounting date are given in Annex -02

1.4.14 REVENUE RECOGNITION

The Government grant for recurrent expenditure and income from research grants, projects and other academic assignments have been recognized as revenue when money is received or realised and all other revenues are recognised on an accrual basis.

1.4.15 EXPENDITURE RECOGNITION

Expenses are recognised in the income and expenditure statement on the basis of a direct association between the cost incurred and the earning of specific items of income. All expenditure incurred in running of the University and in maintaining the properties in a state of efficiency has been charged to the income and expenditure statement.

1.4.16 ACCELERATING HIGHER EDUCATION EXPANSION AND DEVELOPMENT PROGRAM (AHEAD)

During the year ended 31st December 2021, University has received a total of Rs. 370,840,618.01 and out of which amounted to Rs 366,812,215.52 has been incurred for the purpose of the project and the balance money of the project was remained in the bank account operated by the project. The accounts of the project were maintained separately under the supervision of the ministry and which were not associated with the University accounts. The details of the project are given in Annex – 03.

1.1.17 SCIENCE AND TECHNOLOGY HUMAN RESOURCES DEVELOPMENT PROJECT

This project funded by Asian Development Bank will support the university in developing the technology faculty to nurture a new breed of technology-oriented graduates equipped with market relevant skills and entrepreneurial spirit. It will

address lack of financing for priority degree programs, which are in high demand from students and industry. The project will provide innovative and industry-relevant technology education and research facilities, help quality curriculum design and academic staffing aligned with international standards, and provide competitive grant scheme and capacity development opportunities. The total amount of the grant is 25.0 million US dollars and out of this LKR. 304.0 million was spent in 2021 to purchase equipment, conduct workshops etc. Total expenditure of the project up to now is LKR.501.0. Since these assets and expenditure are under the project not include in this financial statement.

Report of the Auditor General on the Financial Statement of the Rajarata University of Sri Lanka for the year ended 31st December 2021 and the other legal and regulations required for that in terms of section 12 of the National Audit Act, No 19 of 2018.

1. FINANCIAL STATEMENTS

1.1. QUALIFIED OPINION

The audit of the financial statements of the Rajarata University of Sri Lanka for the year ended 31 December 2021 comprising the statement of financial performance, statement of changes in equity and cash flow statement for the year then ended, and notes to the financial statements, including a summary of significant accounting policies, was carried out under my direction in pursuance of provisions in Article 154(1) of the Constitution of the Democratic Socialist Republic of Sri Lanka read in conjunction with provisions of the sub section 107 (5) of the Universities Act No. 16 of 1978 and National Audit Act No. 19 of 2018. In terms of sub-section 108 (1) of the University Act, this report contains my comments and observations which I intend to publish with the annual report of the University. According to Article 154 (6) of the Constitution, my report will be tabled in Parliament in due course.

The Financial Statements of Rajarata University as at 31st December 2020 and the statement of financial performance and the cash flow statement for the year ended have indicated true and fair state in accordance with the Sri Lanka Public Accounting Standards is the my opinion except the matters affected explained in the basis for qualified opinion in my report.

1.2. BASIS FOR QUALIFIED OPINION

- (A) In accordance with paragraph 65 of No 07 of Sri Lanka Public Sector Accounting Standards, the effective life of the noncurrent Assets had not been reviewed annually and the 12 assets subjects, which were completely depreciated, amounting to Rs. 879,604,581, continued to be in use furthermore. Therefore, the estimated error had not been revised in accordance with No 03 of Sri Lanka State Accounting Standards.

- (B) In the reviewed year, the completed 04 construction projects, which spent a total value of Rs. 10,893,922, had not been transferred to the relevant assets accounts from the working-in-progress account, due to the cost of property, plant, and equipment was shown in less of equal value as of 31st December 2021. Furthermore, due to the non-accounted of depreciation value of the above assets amounting to Rs. 406,566, the surplus in the reviewed year has been shown as an overstated value equal to the above. Further, Rs.15,767,310, spent on non-building assets that had been completed but not capitalized in the previous year, has not been transferred from work in progress account to the building account during the year under review and therefore, the cost of the asset accounts with the same value is shown more and less respectively.
- (C) During the period from 2015 to 2021, the cost of expenditure amounting to Rs. 1,027,676,497, for constructing the 02 buildings on land which not owned by the university had been capitalized. Further, the cost of purchase during that period spent for purchase of medical equipment amounting Rs. 23,999,000 which should have been depreciated from the beginning, amounting to Rs. 16,799,300 not depreciated.
- (D) Due to the expired stock's cost with no realization value of Rs. 4,730,583 has been included in the balance of the year-end stock, the surplus of the reviewing year and the current assets as on 31st December 2021 are overstated by the equal value.
- (E) As the bond, amounting Rs.3,784,401, which was included in the bond violation debtor's account balance Rs. 69,717,263 as of 31st December 2021, had been renewed until 2023 in the reviewing year, the aforesaid amount should have been removed from the debtors' account, but it has not been done and therefore the surplus of the reviewing year and the account balance of the bond violation debtors' account of the year-end 31st December 2021, have been shown overstated by an equal amount.
- (F) The amount of Rs.2,711,041 which received between years 01 and 05 and was not identified but has been credited to the miscellaneous deposit account.
- (G) The donations Rs. 1,791,447 for 2253No's books and journals during the period from 2017 to 2021, these were not accounted for in the reviewed year.

- (H) Although, the deduction of 10% should be made by salary from the officers who owned quarters as per the commission circular no 09/2019 dated 25th November 2019 of the University Grant Commission, the amount of Rs. 274,210 which was due from the quarters that were allocated to the Vice-chancellor and Registrar of the University was not recovered and accounted accordingly, the surplus of the reviewed year and the current assets of the year-end 31st December 2021 have been shown less by an equal amount.
- (I) During the reviewing year, the detailed schedules for the 03 transactions of the computable value of Rs. 262,772,409 had not been submitted for audit.
- (J) According to the stocks verification reports as of 31st December 2021, reasons for differences amounting of Rs. 211,700 between the stocks balances and the stock balances shown in the financial statements as of that date, had not been submitted.

The auditing has been carried out in accordance with the Sri Lanka Auditing standards. Further to the responsibility under these auditing standards has been explained in the responsibility of an auditor in relation to the auditing of the financial statements. I have faith that the auditing evidences obtained were sufficient and appropriate for the making basis to my qualified opinion.

1.3 **OTHER INFORMATION INCLUDED IN THE 2020 UNIVERSITY ANNUAL REPORT**

The other information means that the information which has been included in the annual report of the year 2021 which is expected to be handed over to me after the date of audit report and the same information not been included in the financial statements and the Audit Report. The management is responsible for this other information.

The other information does not cover from my opinion given with regard to the financial statements and do not authenticate or state any opinion to that effect.

According to the auditing of the financial statements, my responsibility is to read the identified other information received and by doing so the knowledge obtained through other financial statement, auditing or other means to see the in appropriateness in quantitatively.

When reading the university Annual report 2021 , if I conclude that there are qualitative errors, those matters shall communicate to the controlling authority for correction. Further, those errors are existing without correction, those would be included in the report which is table at the parliament in due course in accordance with the 154 (6) of the constitution.

1.4 MANAGEMENT'S AND ADMINISTER'S RESPONSIBILITY REGARDING THE FINANCIAL STATEMENT

The management is responsible for the preparation and fair presentation of these financial statements in accordance with the Sri Lanka Public Sector Accounting Standards and for such internal control as the management determines is necessary to enable the preparation of financial statements that are free from material misstatements whether due to fraud or error.

It is the responsibility of the management to decide whether to continue of maintaining the University when preparing the financial statements. If the management is in the opinion of that the University of Rajarata to be handed over to the government or lease the operation when there is no alternative for except that, the accounts should be maintained on the basis of continuance and the disclosure of the matter whether to maintain the university continuously is also the responsibility of the management.

The responsibility of the financial reporting process finance should be taken by the Governing authority of the university.

In accordance with the sub - para 16 (1) of No 19 of 2018 National Audit Act, the university should maintain the books and record of all income, expenditure, assets and liabilities in order to enable the preparation of annual and timely financial statements of the university.

1.5 AUDITOR'S RESPONSIBILITY TOWARDS THE AUDITING FINANCIAL STATEMENTS

As a whole, an audit involves performing procedures to obtain audit evidence about the amounts and disclosure in the financial statements. It is intended to given reasonable opinion as the financial statements do not reflect true and fair picture due to fraud and errors.

When carrying out auditing according to the Sri Lanka Auditing standards, it always does not mean that qualitative disclosure about the financial statements could confirm. Further, the economic decision taken by following this report definitely could affect their decision.

I have been carried out auditing with the professional judgment and suspiciously according to Sri Lanka Auditing Standards. Furthermore,

- ❖ When finding a base to declare the audit opinion, whether due to fraud or error in making those risk assessments, including the assessment of the risk of material misstatements of financial statements. This could be stopped by adopting sufficient and appropriate suitable audit evidences. The damage to the fraud is higher than the damage caused by mispresertation when those preparation of fake documents, ignoring purposely, mispresenting or the ignoring internal controls.
- ❖ In order to planning the suitable periodically auditing system, study carried out about the internal control of the university not to give an opinion about the effectiveness of the internal control.
- ❖ It has been appreciated that adopting of reasonable accounting policies and estimates and the relative disclosures by the management.
- ❖ In order to consider the continuance of the university activities due to the incidents and reasons through the audit evidence obtained, it is decided to adopt the basis of continuance process for accounting. If there is a reasonable doubt the basis of continuance in operation, it should be disclosed in the final statement and if those disclosures not enough the auditor's opinions to be highlighted. However, continuance in operation would be closed due to future incidents and situations.
- ❖ The presentation of financial statements with disclosures structure and content were appreciated. The transactions and the incidents for those affected have been included in the final statements.

Identified the important audit observations, main mistakes in the internal control and other weaknesses informed to those who control the activities.

REPORT ON OTHER LEGAL AND REGULATIONS REQUIREMENTS

- 2.1 The special provisions have been included for the following requirements in the No 19 of 2018 National Audit Act.

- 2.1.1 As per the requirement of clause 12 (A) of No 19 of the 2018 National Audit Act, except the matters affected are explained based on qualified opinion in my report, I have obtained all other details and information for my auditing and it is my opinion that the University is maintaining proper financial report.
- 2.1.2 As per the requirement of clause 6 (i) (B) (iii) of No 19 of 2018 National Audit Act, the financial statements forwarded by the University is agreeable with the previous year.
- 2.1.3 As per the requirement of clause 6 (i) (C) (IV) of No 19 of the 2018 National Audit Act, except the observations are mentioned in the based on qualified opinion 1.2 (A) and (B) sections of my report, the recommendations made in the previous year have been included in the forwarded financial statements.
- 2.2 There was no attention to express anything below due to the fact that the process followed, obtained evidences and limit to the important matters etc.
- 2.2.1 As per the requirement of section 12(D) of No 19 of 2018 National Audit Act except the following observation, a council member of University could directly deal with the same agreement or other way if the connection deviation from the normal activities.
- 2.2.2 As per the requirement of section 12 (E) of No 19 of 2018 National Audit Act except the following observation, action has not taken in accordance to the relevant written Laws or the special or common orders issued by the council.

- (B) Finance regulation of the Democratic Socialist Republic of Sri Lanka Finance Regulation 571 (2) Actions have not been taken according to the financial regulation regarding the tender deposit of Rs. 1,492,092 from year 2017 to 2019 and miscellaneous deposit of Rs. 1,729,464 from year 2016 to 2019 and contract and miscellaneous retention money total Rs. 137,470,912 from 2010 to 2019 years.
- (C) XIX chapter of the Establishment Code of the Democratic Socialist Republic of Sri Lanka
- (i) 5.2.1 Paragraph Quarters facility has been granted to 81 of the officers in the university of reviewed year and, although it should be recovered 12.5% of the salary of married officers who own permanent houses and 7.5% of the salary of unmarried officers who own permanent houses, it has been charged only Rs.750 and Rs. 1,500 respectively on behalf of the house rent.
- (ii) 5.2.3 Paragraph The economic rent of the 31 quarters named chamary houses was not assessed and it had been charged from a minimum of Rs. 400 to a maximum of Rs. 750.
- (D) 3.1 paragraph of chapter XX of the Establishment code of University. Though, all employees serve at the higher education institutions shall mark the arrival and

departure times, the academic staff had not done so.

- (E) 2.10 Paragraph of the guideline for research allowances of Rajarata University of Sri Lanka Although the research advances should be settled within 90 days, the advance, amounting to Rs. 1,008,427 which was granted for 9 officers within from 2008 to 2021 had not been settled as at 30th May 2022.
- (F) 3.3 Paragraph of the guideline for research allowances of Rajarata University of Sri Lanka Although the advances which issued to the officers who are not handed over the final research paper to the research committee should be recovered from 4 installments of their salary, the amounting of Rs. 2,671,318 released by 31st December 2021, which were issued to officers for approved researches from the years 2017 & 2018, and had not handed over their research papers to the research committee, had not been recovered from their salaries.
- (G) Commission circular 09/2019 of University Grant Commission dated 25th November 2019 Although the water bill and electricity bill which are relevant to the quarters should be paid by the beneficiary of the house, the amounting of Rs. 197,917 for the water and electricity bill of the Vice Chancellors' quarters had been paid by the University.

- (H) 4(ii) paragraph of Management Service circular 02/2014 dated 11th February 2014
- Although the interim research report, which is included progress accordance with research proposal activity plan, should be presented to the research management committee within 06 month from start date of research, the interim progress reports for the 08 research which was approved and started in 2018 and intern progress reports for every research, which were approved and started in year 2021, had not been presented to the research management committee.

2.2.3 As per the requirement of the section 12 (h) No 19 of 2018 National Audit Act, the university has acted not according to the university authority, performance and the power.

2.2.4 According to the requirement of section 12 (h) of No 19 of 2018 National Audit Act, except following observations, the university has not utilized its resources efficiently, effectively and carefully not following the procurement procedure in accordance with the rules and regulations periodically.

(A) An overpayment of Rs. 173,696 has been made to the contractor for Asphalt metric ton 13.57 for constructing the access road with 50mm thickness of wearing space layer at Faculty of Agriculture,.

(B) The University had finished the project of constructions the 04 unit of staff twin quarters in the Mihinthale premises on 20th February 2019. Performance bond amounting of Rs.3,952,742 expired on 2018.02.12 and advance bond amounting of Rs. 10,540,647 expired on 2018.03.05 and it had not make necessary action to renew or en-cash the above agreements. Therefore, the university had to take legal action to recover the amount Rs. 15,760,011 from the contractor as to date of cessation of the agreement.

- (C) Staff loan amount of Rs.698,580 which was issued between years 02 and years 17 to the pensioners, resigned and interdicted employees in the university, had not recovered duly.
- (D) An amount of Rs. 550,000.00 spent for the researches work from total estimated amount Rs.2,700,000 of the approved and started 03 research and it was recorded 20.3% of the estimated amount. Accordingly, aforesaid researches were unable to execute duly and it had not been completed by December 31, 2021.
- (E) Although the contract had been awarded to the selected supplier who submitted the contract value Rs. 6,211,226 for the installation of air conditioner system to the Faculty of Management, due to delay in sending the contract acceptance letter for the above construction about 02 months, the contractor rejected to accept the above letter. Even then, the bid security bond expired and could not be able to en-cash in the same.
- (F) The University had been awarded the contract to the selected bidder for the develop the ERP system with the contract value of Rs.17,500,000. However, it has been granted without considering, that the contractor had not submitted a bid security bond with the relevant format, the awarded and the completed letters for the main 05 constructions which were completed in the last 05 years, have not been submitted duly and the minimum average annual income Rs. 52.5 million had not been earned by the bidder in duly. Although the contractor should have completed the new ERP system and handed it over to the University as of 31st December 2021, it has not been handed over to University even by 02nd May 2022.

2.3 The matters that should have not been included in the Internal Auditor's scope had been included in the Internal Auditor's duty list and internal audit plan. Therefore, the main function of the Internal Auditor, which is the responsibility of reporting the activity of the internal control system of each department, had not been fulfilled. Further, the independence of the internal auditor had been similarly limited.

CLARIFICATIONS OF THE CURRENT ACTIONS TAKEN BY THE UNIVERSITY IN RELATION TO THE FINANCIAL STATEMENTS AND OTHER LEGAL AND REGULATORY REQUIREMENTS OF THE RAJARATA UNIVERSITY OF SRI LANKA FOR THE YEAR ENDING DECEMBER 31ST 2021, IN ACCORDANCE WITH SECTION 12 OF THE AUDITOR GENERAL'S REPORT, NO.19 OF 2018.

1. FINANCIAL STATEMENTS

1.1 QUALIFIED OPINION

1.2 BASE FOR QUALIFIED OPINION

- (A). This has been delayed by closing the university from time to time due to the Covid epidemic in the year 2022. The financial statement of the year 2022 will be forwarded within the relevant adjustments accordingly.
- (B). Out of 04 projects, the value of two projects of Rs. 1,007,740.00 has been adjusted to the building asset account in the year 2021. Action will be taken to adjust the value of Rs. 15,767,310.00 for road constructions and evaporation trays from the building account to infrastructure account in the year 2022.
- (C). Action will be taken to hand over the prop unit and security hut to the general hospital Anuradhapura. The Eco – Cardiography machine has been purchased for prop unit from the provision of UGC in the year 2022 and all the maintenance and services done by the general hospital Anuradhapura. This will be adjusted accordingly in the year 2022.
- (D). Three committees have been appointed for this purpose and action is being taking to forward the committee reports to the Audit and management committee and to get the approval of the council for committees' recommendations. The council's decisions will be adjusted to the financial accounts in the year 2022.
- (E). This will be adjusted in the year 2022.
- (F). Action will be taken to add to the income after identifying the accurate income of this account.
- (G). Action will be taken to take these books of stocks into the assets account in the year 2022.
- (H). The commission inquired about the University Grand Commission circular letter 09/2019 and it was informed that house rent can be charged based on the decision of the housing committee of the university. Accordingly, following the prescribed procedure, the university approved the revised house rent amount on the recommendation of the housing committee

- (I). This has already been prepared and action will be taken to forward for Auditing.
- (J). Action will be taken to find out the difference and correct accordingly.

1.3 OTHER INFORMATION INCLUDED IN THE UNIVERSITY 2021 ANNUAL REPORT.

2. REPORT ON OTHER LEGAL AND REGULATIONS REQUIREMENT

2.1 The special provisions have been included in the No 19 of 2018 National Audit Act for the following requirements.

2.2. There was no proof for my attention to make following statements on the process followed and evidence obtained or limitations to the quantitative matters.

2.2.1. In accordance with the requirements of clause 12 (අ) of No 19 of 2018 National Audit Act, the member of university council in respect of an agreement about the university whether directly or indirectly have a relationship except the normal business.

2.2.2. Except the following observations in accordance with the requirement of clause 12 (ආ) of No 19 of 2018, the action has not been taken of any written laws or common or special orders issued by the university council member.

RULES AND REGULATIONS/ REFERENCE TO ORDERS

(A) The daily activities of the university are currently carried out through various information and communication systems, and in the year 2021, the initial stages were carried out to establish an integrated University Management Software Solution System (ERP System) for all these systems. Accordingly, from the end of 2021, the training sessions of this new system were started. Therefore, under task number 11 in the internal audit plan of the year, this system has been used to carry out related review activities.

(B) Action will be taken to identify correctly this and taken into income in future.

(C) Chapter XIX of establishment cord of the Democratic Socialist Republic of Sri Lanka.

(i) Section 5.2.1

As per the inquiry with the University Grant Commission, it was informed that the decision can be made by the University housing Committee based on the location of the university and the number of employees. Accordingly, the committee has made relevant amendments. House rent is charged for these official residences by the housing committee which is a sub – committee of the council.

- (ii) Section 5.2.3
As per the inquiry with the University Grant Commission, it was informed that the decision can be made by the University housing Committee based on the location of the university and the number of employees. Accordingly, the committee has made relevant amendments. House rent is charged for these official residences by the housing committee which is a sub – committee of the council.
- (D) Action will be taken to rectify in the future.
- (E) The advance of (05) five out of 09 officers (Rs. 50000.00) have been settled so far. Action will be taken for unsettled advances on the decision of the Audit and Management Committee in future.
- (F) The necessary action is being taken by the research committee presently.
- (G) Action has been taken to correct.
- (H) The necessary advice has been given by the research committee to obtain the progress by 06 months. The research committee has taken a decision to take action for not giving correct research progress. The observation points were correct and action will be initiated to prevent same in future.
- 2.2.3. In accordance with the section 12 (e) of 2018 No 19 National Audit Act the university had not acted accordingly with regard to authority, duties and activities.
- 2.2.4. According to the requirement mentioned in section 12 (e) of the National Audit Act No. 19 of 2018, apart from the following observations, the university's resources have not been procured and use in accordance with the relevant rules and regulations in a frugal, efficient, and effective manner.
- (A) The above mentioned project was done through two contractors. Although M/S Kasunsandu construction private Limited was selected as the first contractor through the procurement process and awarded the contract, the university had taken steps to terminate the contract, midway due to the contractor's non – fulfillment of the contract for more than four months. Through re – procurement, M/S Dissanayake Construction Company was selected for the balance work and the first contractor had completed the paving ABC on this road and the concreting of the Dish Drain on one side. The thickness of this bitumen layer has exceeded 50mm in the course of laying the asphalt with the right quality by giving the correct water level to this Dish Drain. Therefore, the university concludes that this additional amount has been spent because two contractors have avoided the quality losses that occurred in this work and went to perform the work of high quality, and it is implied by the above facts.

(B) Although the technical evaluation committee held on 16.12.2016 had recommended to pay the advance amount of 20% in two installments, the advance amount of 20% related to this project has been arranged to be paid to the contractor at once on the approval of the 213rd departmental procurement committee held on 21.12.2016. The decision of the departmental procurement committee as per section 2.5.1 section 8.1.1 of the code of procurement guidelines shall be final. As 20% advance amount has been paid in lump sum as per the decision /approval of 213rd Departmental Procurement Committee held on 21.12.2016 no overpayment has taken place. Payments have been made to the contractor for 03 installments and an amount of Rs. 1,564,094.86 has been recovered out of the total advance amount of Rs. 10,540,647.20.

The advance guarantee has expired on 05.03.2018 and the performance guarantee has expired on 12.02.2018 and the contractor has been inquired by letters dated 17.04.2018 and 24.04.2018 to extend the period of those guarantees. According to the notices, a copy of the letter sent by the contractor to the DFCC bank on 03.05.2018 to extend the period of the respective guarantees has been forwarded to the university. Assistant Registrar Capital Works also sent a letter to the contractor on 02.07.2018 to correct it as vice – Chancellor as the employer was named as Assistant Registrar Capital Works in that reference letter. Further, the contractor has agreed to complete the remaining works and give extended guarantees in the progress review committee held on 24.04.2018.

Furthermore, in the special meeting between the university and the contractor held on 18.06.2018, the contractor has agreed to extend the period of the relevant guarantees and give them to the university and same decisions have been approved in the 225th Governing Council Meeting. Therefore, the university's effort was to complete this project through the same contractor company as per the agreement of this contractor. However, the legal process is being carried out as per the contract agreement to recover the loss from the contract company due to the termination of the contract on 20.02.2019. As notified to the contractor by the works engineer on 13.09.2017, 16.10.2017, 28.11.2017 and 14.02.2018 and the review was conducted on 27.09.2017, 27.12.2017, 24.04.2018, 18.06.2018 and 02.10.2018 as mentioned in the meetings, this contractor has maintained this project with low progress since the initial stage of the contract. As mentioned in the works engineer's letter dated 16.10.2017 and 28.11.2017, the work of the project has been carried out intermittently. This low progress has been discussed at length in the progress review committee meeting held on 24.04.2018, where the contractor has shown no hope to complete this project. He has also made a request to the bank to extend the guarantee as requested in that meeting. The progress review committee meeting reports held in 2018 reflect that the university had no desire to complete this project and transfer this project to someone else through another procurement plan and this contractor has made efforts to complete this project. But due to financial difficulties of the contractor, this contract has been completely stopped by August 2018 and even then, the guarantees have not been extended as requested by the university. Therefore,

considering the practical situation at that time, I state that the management of the university is correct.

- (C) Arrangements will be made to recover the respective loans when release of the provident funds of these employees.
- (D) It is observed that various practical problems have affected this. But from now on, research funding and physical progress will be pursued. It is also decided to plan research and ask the reasons for the weakness from those officials.
- (E) The award of the contract has not been delayed as the country was closed due to the corona epidemic that lasted from 20.08.2021 to 01.10.2021. and since the bid protection expired when the country was closed, it was not possible to request an extension. Also, this contract has not been converted into another contract and the departmental procurement committee has decided to re call bids.
- (F) That the validity period, value and manner requested by us in the terms and conditions of the bid documents published by us are offered in accordance with the requested procedures and that the large distributions of the bid securities offered (underwriting of value reduction, underwriting of validity and with conditions submission) was accepted as a valid bid security by the Security Technical Evaluation Committee.

There was no bidder who fully loaded the pre – qualifications of all the bidders submitted and the Technical Evaluation Committee was satisfied with the pre – Qualifications submitted by the tenderers and accordingly further evaluation was carried out. Accordingly, the most optimally qualified tenderer was selected here and the university excludes that the bid was awarded without rejecting the selected bidder despite the non – compliance and this is an optimally evaluated contract and given the opportunity to the tenderer who confirmed the highest suitability according to the relevant specifications. Also as stated in the audit report, if an average annual income of 52.5 million rupees should receive as an evaluation figure, the Technical Evaluation Committee was of the opinion that no competitive bids would be submitted and our approved estimated amount is 17.5 million rupees. 20 million is revenue has been requested in the bid documents and all the bidders have met this parameter.

Details of five major contracts completed by the bidders in the last 05 years have been requested under ITB 11.1.5 of bid data sheet, but none of the contractor had not provided this information properly. These information evaluation and eligibility criteria are not criteria for evaluation of bid as stated in chapter 03. This information is merely information requested to ascertain the continued existence of bidders in the field. And this has been further analyzed under No. 08 of the Technology Committee Report held on 17.08. 2020. Although the last 05 years financial reports of the bidder were to be submitted, only the average income of three years was considered as bond evaluation parameters. Accordingly, The Technical Evaluation Committee

evaluated the average income of the previous three years by using the arithmetical published financial reports of the nearest three years. Accordingly, since all this bids met the criteria for the average income of the last three years, the technical evaluation committee decided that these bids were qualified bids.

In considering the average annual income, the cost of the goods intended to be purchased as well as the frequency of sale of the goods, the nature of the goods and their ability to be sold in general are all taken into consideration and since this type of system is non – commercial, the minimum annual income should be 4/3 of the estimated value it was decided that. Accordingly, the Technical Evaluation Committee observed that selected bidder was an organization earning more than the annual revenue claimed in the bid documents. Accordingly, it is ruled out that this was not checked by Technical Evaluation Committee.

Due to the situation prevailing in the country from 01.01.2021. to 30.06.2021 due to the closure of the university due to covid, due to the online system and the use of 50% minimum number of employee, it is not possible to carry out the work of this system properly. And as requested by the contractor, the 225th departmental procurement committee held on 18.08.2021 has approved to extend the contract period up to 31.12.2021. As some changes had to make in the various modules during the course of the system, the contractor requested for further extension of the contract period, which was submitted to the procurement committee for consideration and another extension was obtained up to 30.06.2022. Accordingly, I would like to inform you that late fees are not applicable at this time. According to 2.8.4. of the procurement guidelines, the appointment of members for the technical evaluation committee for this procurement as well as other procurements of the university has been appointed by the head of the institution, the Vice Chancellor, and based on that approval, the assistant finance manager, who dealt with this procurement, referred the technical evaluation committee to the relevant committee officers. Appointment letters have been forwarded for. The university disagrees that the contract data, tender data and instructions mentioned in the audit query were changed after the tender documents were issued. I would like to inform that the university published the bid documents approved by the departmental procurement committee and only those approved bid documents were followed till the end of the procurement process.

The university disagree that the sub – dimensions mentioned in the audit question and the mode of scoring for the sub – dimensions were not mentioned. Chapter 03 on how to evaluate qualified bids as per paragraph 7.9.1 (a) of the Government Procurement Guidelines Code clearly states the evaluation and qualification sub – parameters. The manner of scoring is not specified in the bids and the scoring procedure is clearly noted in the score sheet and the rankings are submitted with the approval of the departmental procurement committee. The university conducted this procurement under these items and for that purpose. The national procurement Agency prepared all the bid documents related to the SBD/01 forms and accordingly it is felt that is not necessary

to make an inquiry again with the National Procurement Agency. The Technical Evaluation Committee determined that an information system is specific and not a complex information system, which was intended to be procured under items through SBD/01 bid documents. Accordingly, the Departmental Procurement Committee approved the bid documents and the relevant contractor will prepare the requirement, scope and items of reference as a specific information system under the goods. According to the facts mentioned above, the Technical Evaluation Committee selected and recommended the qualified bidder who submitted the minimum proposal in the financial proposal according to the tasks that meet our needs as mentioned in the tasks 01 from the two bidders who came forward for this procurement and the relevant project was started with the approval of the departmental procurement committee.
