DETERMINING THE EFFECTIVE DATE OF PROMOTION TO THE POST OF SENIOR LECTURER GRADE II (MEDICAL/DENTAL) IN RECEIPT OF THE BOARD CERTIFICATION OF THE PGIM

Your reference is invited to the Schemes of Recruitment of the posts concerning the Medical/Dental category of the academic staff given in Commission Circular No. 721 of 21.11.1997 as amended by Commission Circular No. 996 of 09.10.2012 and also to the Establishments Circular Letter No. 08/2016 of 11.10.2016 regarding the above matter.

- 02. The Commission at its 973^{rd} meeting held on 12.10.2017 having reviewed the provisions made by Establishments Circular Letter No. 08/2016 decided to revoke the paragraph 02(ii) of such circular letter.
- 03. Accordingly, the Establishments Circular Letter No. 08/2016 of 11.10.2016 is hereby rescinded with immediate effect and the following provision which came into force under paragraph 02(i) of that circular letter, will continue in operation;

"If a candidate who was awaiting Board Certification of the PGIM at the time of submission of his/her application for the post of Senior Lecturer Grade II (Medical/Dental), has obtained the Board Certification at the time of appearing at the Selection Committee, he/she shall be considered for the post of Senior Lecturer Grade II - (Medical/Dental) provided he/she possesses 06 years' experience as per Post No. 4 of Commission Circular No. 721."
